Leveling the Playing Field explores the technologies that “trickle down” to the rest of us, those that were once the domain of the wealthy and powerful--and which therefore tended to make them even more wealthy and powerful. Now, though, these technologies--from books to computers to 3D printing and beyond--have become part of a common toolkit, one accessible to almost anyone, or at least to many more than had heretofore had access. This is what happens with most technologies: They begin in the hands of the few, and they end up in the hands of the many. Along the way, they sometimes transform the world. This timely book inspires researchers to deploy relevant, effective, innovative digital methods. It explores the relationship of such methods to 'mainstream' social science; interdisciplinarity; innovations in digital research tools; the opportunities (and challenges) of digital methods in researching social life; and digital research ethics. Advances in close-range and remote sensing technologies are driving innovations in forest resource assessments and monitoring on varying scales. Data acquired with airborne and spaceborne platforms provide high(er) spatial resolution, more frequent coverage, and more spectral information. Recent developments in ground-based sensors have advanced 3D measurements, low-cost permanent systems, and community-based monitoring of forests. The UNFCCC REDD+ mechanism has advanced the remote sensing community and the development of forest geospatial products that can be used by countries for the international reporting and national forest monitoring. However, an urgent need remains to better understand the options and limitations of remote and close-range sensing techniques in the field of forest degradation and forest change. Therefore, we invite scientists working on remote sensing technologies, close-range sensing, and field data to contribute to this Special Issue. Topics of interest include: (1) novel remote sensing applications that can meet the needs of forest resource

information and REDD+ MRV, (2) case studies of applying remote sensing data for REDD+ MRV, (3) timeseries algorithms and methodologies for forest resource assessment on different spatial scales varying from the tree to the national level, and (4) novel close-range sensing applications that can support sustainable forestry and REDD+ MRV. We particularly welcome submissions on data fusion. India has the world's fourth largest military and one of the biggest defence budgets. William Watson Cheyne (1852-1932), a surgeon by training and a student of Joseph Lister, was a prominent British bacteriologist who published 60 papers and 13 monographs from 1879 to 1927. A proponent of the idea that bacteriology and medicine were interdependent disciplines, he investigated the causes and treatment of wound infections, tuberculosis, cholera, tetanus and gangrene. In 1897, he organized an historical outline of 19th century bacteriology in five landmark periods of discovery, each defined by the work of an influential figure. This study documents his contributions to the history of microbiology and describes his activities as a laboratory investigator, clinician, surgeon, translator, editor and educator. This volume looks at the impact of the landmark 2014 elections and the consequent Assembly elections which have transformed the ideological discourse of India. Secondly, it examines the development trajectories of these movements. Thirdly, it looks at the best way to explain their impact and development patterns, and finally it assesses their overall impact, questioning whether they can be regarded as successes or failures. Covering a unique range of social movement cases, the book will be of interest to students and researchers interested in Taiwanese society and politics, as well as social movements and civil society. The migration of Ethiopians across international borders is a recent phenomenon because of the limited integration of the country and society to the global economy. Since it was never colonized - aside from the Italian occupation of 1936-1941 - Ethiopia's economy and society were not directly impacted by the ebb and flow of the global economy, and thus never generated international migration. Beginning in the 1970s, due to factors such as famine, rural poverty, civil war, and political

repression, an unprecedented number of Ethiopian migrants began to leave their country in search of better, more secure lives. Today, this diaspora constitutes a distinctive community dispersed across the world, but bound by a common feeling of collectiveness and a shared history of the homeland. The contributors to this volume draw their work from a wide variety of interdisciplinary fields and provide new critical insight on Ethiopian migrants and their diaspora communities. What has emerged from these scholarly works is the recognition that the Ethiopian diaspora - although separated by oceans and nations, by politics, ethnicity, class, gender and age - are carving out a social and material world born out of their particular circumstances both "here" and "there".
