It addresses the global dominance of neoliberalism, and the extent to

which practitioners, activists and programmes can challenge, critique, engage with or resist its influence. Addressing key dilemmas and challenges being navigated by students, academics, professionals and activists, this is a vital intellectual and practical resource. This 50th anniversary publication provides a comprehensive history of community development. Beginning in 1970 with the advent of the Community Development Society and its journal shortly thereafter, Community Development, the editors have placed the chapters in major themed areas or issues pertinent to both research and practice of community development. The evolution of community development as an area of scholarship and application, and the subsequent founding of the discipline, is vital to capture. At the 50-year mark, it is particularly relevant to revisit issues that reoccur throughout the last five decades and look at approaches to addressing them. These include issues and themes around equity and inclusion, collective impact, leadership and policy development, as well as resilience and sustainability. Community change over time has much to teach us, and this set will provide a foundation for fostering understanding of the history of community development and its focus on community change. The chapters in this book were originally published in the journal Community Development. Introduction to Community Development provides students of community and economic development with a theoretical and practical introduction to the field of community development. Bringing together leading scholars in the field of community development, the book follows the curriculum needs in offering a progression from theory to practice, beginning with a theoretical overview, an historical overview, and the various approaches to community development. There is a tremendous need for community development practice in the Asia-Pacific region due to its size and prevailing diverse socio-economic, political and cultural needs and issues. Both developed and developing countries have been reemphasizing the importance of community development and have introduced several schemes or programs for overall development. Manohar Pawar familiarizes readers with the region, presents the major social, economic and political issues, looks at values and principles, and critically analyses challenges and shows opportunities for community development practice in the region. This book will allow for anyone interested in community development both at local and global levels - scholars, non-government organizations (NGOs), government organisations, international aid agencies - to gain a broad understating of community development trends in the Asia-Pacific region. This book explores the intersection of community development and local capacity building as a basis for effective disaster mitigation and the alleviation of suffering in times of crisis. Beginning with the Community Development section, the process, context, and methods for community, engagement, and development can be viewed from

different structural and logical approaches. This section explores some of the more relevant historical arguments, as well as more contemporary examinations. The second section looks at Critical Human and Community Considerations and sheds light on some of the key concepts that are often overlooked (poverty, race, inequality, social justice, mental health, social division) when framing community responses to disaster. The third section focuses on Fundamental Elements of Caring Communities. This section explores the importance, practical, and measurable impacts of social support, empathy, inclusion, and conflict resolution in creating effective and caring community responses. Finally, the last section focuses on practice and brings together research and theory into applied programming, examples, and evidence from on-the-ground efforts to establish caring communities that respond to local needs in times of crisis and beyond. By addressing these objectives, this book provides a more complete understanding of the essential role that community can play in disaster mitigation. Doing this will provide a better focus for ongoing research endeavors, and program and policy initiatives at the community level that seek to prepare for, respond to, and recover from natural and other disasters. As a result, this book contributes to wider and more sustainable development of our communities beyond disasters, while furthering dialog among community scholars and practitioners. This timely Research Handbook offers new ways in which to navigate the diverse terrain of community development research. Chapters unpack the foundations and history of community development research and also look to its future, exploring innovative frameworks for conceptualizing community development. Comprehensive and unequivocally progressive, this is key reading for social and public policy researchers in need of an understanding of the current trends in community development research, as well as practitioners and policymakers working on urban, rural and regional development. This thesis documents almost twenty years of the author's work on the development and implementation of a new approach to holistic community development in remote and disadvantaged villages in Nepal. It describes the theoretical basis of the work, the main research activities, and the practical outcomes of the implemented programs. One of the fundamental cornerstones of holistic community development is the provision of appropriate and sustainable solutions for the long-term development of local communities. This requires that people's own identified needs be recognized and addressed in partnership with them in holistic ways. The author explains the many synergies that result from this holistic approach to community development. Another cornerstone of his approach is to utilise the communities' locally available renewable resources for long-term sustainable development. One of the key findings of the thesis is that improved access to energy services, such

as cooking with a smokeless metal stove in a clean indoor environment, basic indoor lighting, and increased food production and safe food storage (through a greenhouse and a solar drier respectively), need to be at the very heart of any long-term holistic community development project. The thesis demonstrates that tapping into locally available renewable energy resources and converting them, through contextualized and locally manufactured renewable energy technologies, has a central role in long-term holistic community development programs. Such programs are successful because they provide both appropriate technologies and life-changing experiences for the local users involved. Toward Entrepreneurial Community Development is about developing entrepreneurial communities, and goes beyond theories of the firm to demonstrate how local and regional society contributes in important ways to the vitality of entrepreneurs.
